Item 1. Introduction

Sustainable Advisors Alliance, LLC is registered with the Securities and Exchange Commission as an investment advisor and we provide investment advisory services rather than brokerage services. Investment advisory services and brokerage services and fees differ and it is important for the retail investor to understand the differences. This document gives you a summary of the types of services we provide and how you pay. Please ask us for more information.

Item 2. Relationships and Services

What investment services and advice can you provide me?

Services: We provide Portfolio Management Services, Use of Sub-Advisors, Advising on Held-Away Accounts, Financial Planning, Annuity Management Services, and Employee Benefit Plan Services to retail investors. Each IAR manages portfolio's differently, please refer to our ADV part 2B's for more detail.

Monitoring: Each IAR will conduct account reviews at least annually, to ensure the advisory services provided to you are consistent with your investment needs and objectives. The CCO is responsible for ensuring that account reviews are conducted. Financial plans, once prepared and delivered to you, are reviewed annually. We will discuss your investment goals, design with you a strategy to achieve your investment goals. **Investment Authority:** We buy and sell investments in your account without asking you in advance, this is called "**discretionary authority**". We may give you advice and you decide what investments to buy and sell, this is called "**non-discretionary authority**". We offer both discretionary and non-discretionary authority accounts.

Investment Offerings: Our investment advice is not limited to a particular type of security. We provide advice on stocks, bonds, certificates of deposit, municipal securities, mutual funds and options in securities.

Account Minimums: We do not have an account minimum.

Additional Information: Our firm was initially registered with the Securities and Exchange Commission (SEC) on 01/05/2021. The firm is owned by Janet E. Bryan, Laura W. Isanuk, Harold J. Moran, Julie Lynn Skye, Pamela Stamper-Brandt and Krista Stroffner.

Item 3. Fees, Costs, Conflicts, and Standard of Conduct

What fees will I pay?

Principal Fees and Costs: You will pay an on-going negotiable **asset-based fee** of 0.65% to 1.95% at the end of the monthly or quarter for our services, based on the value of the cash and investments in your advisory account. The more assets there are in your advisory account, the more you will pay in fees, and the firm may therefore have an incentive to encourage you to increase the assets in your account. Our negotiable **hourly fee** for financial planning ranges between \$125 and \$500 per hour. Our negotiable **flat fee** range of \$500 to \$7,500 per financial plan. Our **ongoing fee** for financial planning has a maximum annual fee of \$7,500 billed monthly, quarterly, bi-annually or

annually.

Other Fees and Costs: You are responsible for all custodial and securities broker-dealer execution fees charged by the custodian and executing broker-dealer. Our asset-based fee is separate and distinct from the custodian and broker-dealer execution fees. Some investments (such as mutual funds) impose additional fees that will reduce the value of your investment over time.

Additional Information: *You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying. Refer to our Form ADV Part 2A Brochure, Item 5.A.B.C.D. for more detailed information about our fees.*

B. Standard of Conduct

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

Potential Conflicts: The more assets there are in your advisory account, the more you will pay in fees, and the firm may therefore have an incentive to encourage you to increase the assets in your account.

How might your conflicts of interest affect me, and how will you address them?

Additional Information: Other than what has been stated above concerning insurance licensed individuals, we do not have any relationships or arrangements with any other entity.

How do your financial professionals make money?

We are paid by the asset-based fee that is charged to your investment account. The more assets you have in your advisory account, including cash, the more you will pay us. We therefore have an incentive to increase the assets in your account in order to increase our fees. We are also compensated by ongoing, hourly and flat fees and we do not receive commissions from the sale of insurance products to you
